It is understood and agreed that Stonebridge Park Homeowners' Association, Architectural Committee, and the current management company, et al, are not required to take any action to repair, replace, or maintain any such approved change, alteration, or addition, or any structure or any other property. The homeowner and its assigns assume all responsibility and cost for any addition or change and its future upkeep and maintenance.**
